Selected artists for this year's auction and exhibition will be sent an auction contract, which must be signed and returned to the museum with the artwork no later than 5pm on Wednesday, August 1, 2018.

To complement the 21st Annual Art Auction, an exhibition of all art auction selections will be presented in three of the Square's main floor exhibition galleries. Exhibition dates are preliminarily set to August 10 through September 15, 2018. Artists 18 and younger must have parental consent to participate in the auction. 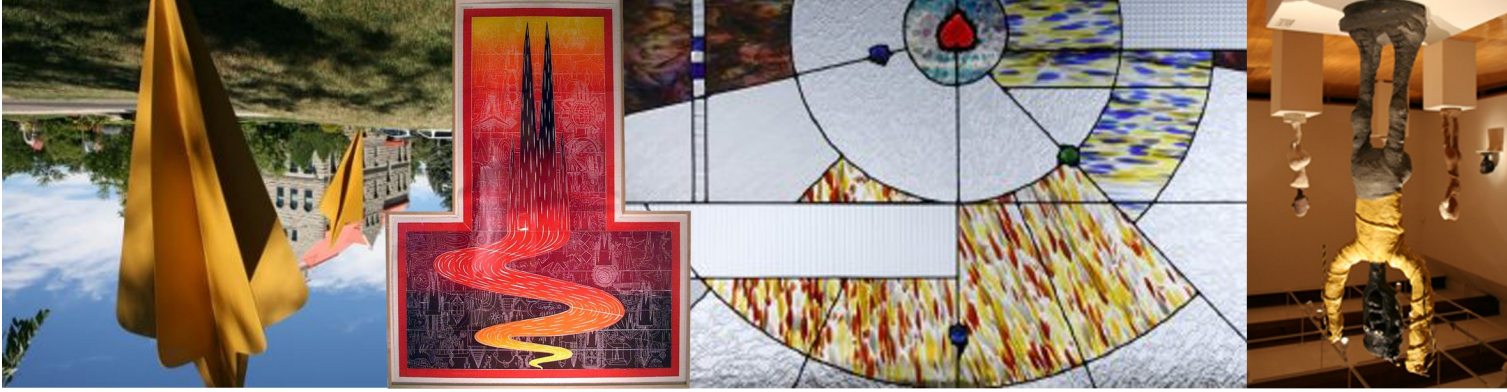
